ROOF:

Control the Dynamic Response of the Tone Color.



INPUT/ DRIVE

Range: - inf to +12 db

Effect:

Increase the saturation (tone color) drive with this control. This control is also affected by the values on the Roof control.

OUTPUT

Range: - inf to +12 db

Effect:

Control the output levels/ make-up gain of this processor.

MIX

Effect: Balance between the dry (original) and wet (processed) sound



ENVELOPE SECTION

Get Compression like tone shaping & dynamics from this section, which is uses an envelope follower rather than traditional dynamics processing. go from "punchy attack" type sounds to "crushed" – sustained like effects.

On/Off

Switch the envelope follower on or off.

MOTION

Range: 0% to 100%

Control the amount of envelope follower going from "splat" to "sharp".

Splat - The more we move toward this end, the more "compression" like characteristics we get.

Sharp - Moving toward "Sharp" makes the sound more "edgy" Saturating more of the peaks in the signal.



ATTACK

Range: 1ms to 500 ms

Effect:

Increase or decrease the attack time of the signal, this works purely in conjunction with the motion parameter.

RELEASE

Range: 1ms to 1000 ms

Effect:

Increase or decrease the release time of the signal, this works purely in conjunction with the motion parameter.



EQUALIZER SECTION

Analog Style EQ Section, further helps in tone sculpting. Features three bands set at musical frequency spots and with the right "q" settings to always get "musical" results. Add or reduce gain at these spots



LOW (85 Hz) Bell Filter

Range:

-15db (left) to 0db (center) to +15db (right)

Add or Cut gain at this frequency (85hz) to bump up or cut the low end in the signal

High (9 KHz) Shelving Filter

Range:

-24db (left) to 0db (center) to +24db (right)

Add or Cut High Frequency from your material using this high shelf filter

LOW CUT

On/Off Button

Effect:

In the on state this engages a 24db/oct Low Shelf filter. This is a useful control to clean up low frequency accumulation.

Mid (1.5 KHz) Bell Filter

Range:

- -10db (left) to 0db (center) to +10db (right)
- Add or Cut gain at this frequency (1.5 kHz) to control presence.



VU METER

The VU Meter can display
either the Input Level or
Output Level of the processor.
This is selectable via the
switch provided.



TONE FOR LOW CUT (50Hz) LOW (85Hz) MID (1.5 Khz) DELETE SAVE

OPEN PRESET FOLDER:

This will open up the folder where presets are stored, and you can easily delete and rename presets here directly or create new preset folders to better organize your presets.

PRESET MANAGEMENT

SAVE: This lets you save your settings to a new preset spot on the root menu or create a folder and put the preset in it.

DELETE: This will delete the current selected preset

To register it, you should have a valid license file (goliath license.atl).


